### RE NOTIFICATION

It is hereby notified that, the Vice Chancellor in exercise of the powers conferred on him as per Section 1 Part II of Chapter XXI of the KUFOS (conduct of Election to various Authorities or Bodies) of First Statute in accordance with the procedure prescribed by the Statute hereby directs to elect 5 Head of the Departments, one faculty member from school of Fisheries Research Management & Harvest Technology and two members from PG students to the Academic Council of KUFOS.

As per Section 17, sub section 1 (x) (xi) and (xii) of KUFOS Act, University Academic Council shall have five Head of the Departments, one faculty members from each school elected from among themselves (now election is conducted for filling vacancy of one elected member from the School of FRM) and two members elected from among the Post Graduate students University.

Only persons, whose names are on the electoral rolls of the respective constituencies, as published by the University on 15.09.2017 and later notified on 17.10.2017 are eligible to take part in the election and to vote thereat, subject to the provisions contained in the Statute. Any person who ceases to be member of an electoral body before the date of issue of ballot paper from University Office shall not be entitled to participate in the election.

Every elector is at liberty to nominate one duly qualified person to fill up each seat. Nominations shall be made in the prescribed form, copies of which can be had from the office of the Registrar, to the electors whose names are on the electoral rolls.
